Setting Up Jobs in QBO

1. Enable “Projects” or “Customers” to track jobs
2. Link all transactions to specific jobs
3. Use Classes for job types if needed

Key Reports

- Job Profitability Report
- Unbilled Costs by Job
- Work in Progress Report
- Cost to Complete Analysis

WIP Schedule Requirements

- Track costs incurred vs. costs estimated
- Track billings vs. revenue recognized
- Calculate over/under billing by job
- Required for accrual-based contractors
